NOTICE is hereby given that the City Council of the City of Baytown will hold a public hearing on **April 22, 2021 in the Council Chambers at Baytown City Hall, 2401 Market Street, Baytown, TX, at 6:30 P.M.**, giving all interested parties the right to appear and be heard on the following item:


- (1) The proposed annexation of approximately 71.66 acres of land in Harris County, Texas, including 69.50 acres of land, legally described as Tract 37A-5, Abstract 21, G. Ellis Survey, Baytown, Harris County, Texas, along with approximately 2.16 acres being the entire width of N. Main Street right-of-way extending northwards approximately 1335.01 feet from the current city limits.

Due to the COVID 19 Disaster and the CDC's recommendation regarding social distancing measures, the public may not be allowed to be physically present at this meeting, as there is a limited amount of space when maintaining the required 6-foot separation from others, unless the Open Meetings Act suspensions no longer apply.
